All the Directors and Senior Managerial Personnel of the Company shall conduct their activities on behalf of the Company and on their behalf with honesty, integrity and fairness. Directors and Senior Managerial Personnel of the Company will act on good faith, responsibility with due care, competence and diligence without allowing their independent judgment to be subordinated. Directors and Senior Managerial Personnel of the Company will act in the best interest of the Company and fulfill the fiduciary obligations.

#### CONFLICT OF INTEREST

Directors and Senior Managerial Personnel of the Company should not enter into any transaction or engage in any practice, directly or indirectly, that would tend to influence him/ her to act in any manner other than in the best interest of the Company. Every Director and Senior Managerial Personnel should make a full disclosure to the Board of any transaction that they reasonably expect, could give rise to an actual conflict of interest with the Company and seek the Board's authorisation to pursue such transactions.

#### COMPANY PROPERTY

Every Director and Senior Managerial Personnel should endeavor to ensure that they use the Company's assets, proprietary information and resource only for the legitimate business purpose of the Company and not for personal gain.

### CONFIDENTIAL INFORMATION

These obligations do not only apply to the Directors Term's but thereafter unless the said information became public.

### FAIR DEALING

Directors and Senior Managerial Personnel should endeavor to deal fairly and not seek to take unfair advantage of the Company through manipulation, concealment abuse of privileged information, misrepresentation of material fact or any other unfair dealing.

### COMPLIANCE WITH RULES AND REGULATIONS

Directors and Senior Managerial Personnel should comply with all applicable laws, rules and regulations for the time being in force. In addition, if any Director becomes aware of any information that he believes constitutes evidence of a material violation any securities or other laws, rules and regulations applicable to the Company or the operation of its business, by the Company or any employee or another Director, then such Director should bring such information to the attention of the Chairman of the Audit Committee.

### INSIDER TRADING

None of the Directors or Senior Managerial Personnel shall derive any benefit nor assist others to deriving benefit by giving investment advice from access to and possession of information about the Company, which is not a public domain and constitute insider information. All Directors and Senior Managerial Personnel will comply with the Company's code for prevention of insider trading which is separately attached.

### DUTIES OF DIRECTORS

Every Director of the Company shall endeavor to comply with the provisions of Section 166 of the Companies Act, 2013 relating to duties of Directors. In addition, Independent Directors shall also perform the duties as prescribed in schedule IV to the Companies Act, 2013 as amended from time to time.

### NON-COMPLIANCE

Suspected violation of the code may be reported to the Chairman of the Board or the Chairman of the Audit Committee. All reported violation shall be appropriately investigated. Any waiver of this code must be approved by the Board of Directors and publicly disclosed if required by any applicable law or regulation.
